Digital Twins 2024 early bird registration is open through Halloween. Save up to \$100 on registration for the conference.


Grad Students: Highlight Your Work with Digital Twins

NIBS Chief Resilience Officer Presents on Lifeline Infrastructure and TurboGrants

Dr. Jiqui Yuan, NIBS Chief Resilience Officer and Head of Engineering, is wrapping a busy quarter of meetings and speaking engagements around resilience and infrastructure.

Through October 4, Dr. Yuan is at the National Emergency Management Association Annual Forum with IEM President and CEO Bryan Koon and NEMA President Russ Strickland, Secretary with the Maryland Department of Emergency Management.

The group is presenting NIBS' TurboGrants™ initiative to the NEMA resilience committee.

TurboGrants is a platform to streamline the mitigation grant application process across federal agencies to better support local government and drive equitable investments in communities disproportionately impacted by disasters. TurboGrants is a novel solution that will leverage technology to simplify the grant identification process, match applicants' needs with appropriate

resources, and provide enhanced technical assistance to expedite resilience-building initiatives.

Also recently, Dr. Yuan presented about lifelines and resilience initiatives at BuiltWorlds' 2024 Infrastructure Conference in Washington and the Big City Emergency Managers (BCEM) meeting. He participated in a high-level roundtable on emerging issues surrounding commercial buildings, resilience, and insurance with the U.S. Green Building Council during Climate Week in New York.

Dr. Yuan also recently keynoted the Disasters Expo USA. His presentation: Designing Disaster Recovery Times: Building Codes and Lifeline Infrastructure Resilience. There, Dr. Yuan discussed the important findings of the NIBS Mitigation Saves study and design for functional recovery.

NIBS' Anne Law recently met with Rep. Paul Tonko and heard him speak about the Indoor Air Quality and Healthy Schools Act of 2024 (H.R. 9131) that he championed at the International WELL Building Institute Healthy Building Policy Summit. NIBS looks forward to working with Rep. Tonko and IBWI on policies to improve IAQ and make buildings healthier.

The group explored harnessing digital transformation in the construction industry to advance initiatives, such as resilience, productivity, and decarbonization.

The workshop focused on digitalization through adoption and alignment of international standards. Each delegation shared and received insight on each nation's journey and identified potential areas where the tripartite group could collaborate further.

The briefing was held in March, and NIBS and industry partners made an appeal for reauthorization of the NEHRP and National Windstorm Impact Reduction Program (NWIRP). Both program reauthorizations expired in September 2023 and 2018, respectively.

Commerce Committee Advances Murkowski's Landslides, Earthquakes Legislation

Wednesday, the U.S. Senate Committee on Commerce, Science, and Transportation favorably reported U.S. Senator Lisa Murkowski's (R-AK) National Landslide Preparedness Reauthorization Act on a strong bipartisan basis. Murkowski's bill, cosponsored by U.S. Senator Maria Cantwell (D-WA), would reauthorize current law for ten years, through Fiscal Year (FY) 2034, and provide the U.S. Geological Survey (USGS) with additional authority and resources to help monitor and prepare high-risk areas for landslides.
